The Annual Election Meeting of the Board of Fire Commissioners, Hamilton Township Fire District No. 2 was called to order by Chairman Vetrano at 2:00 pm. After the Flag Salute and a moment of silence; The Open public Meeting Act and the Uniform Fire Safety Code were given. Roll was called.
